0. GENERAL SAFETY RULES

0.1 SAFETY RULES FOR OPERATORS

Consult the person in charge for details of the applicable safety requirements and accident prevention devices. Do not start the machine if it is faulty.

Before using the machine, make sure all hazards have been removed.

Inform the head of maintenance whenever a fault occurs.

Make sure all the guards and safety devices are present and intact, and check their efficiency.

0.2 SAFETY RULES FOR MAINTENANCE PERSONNEL

The area where maintenance is carried out must be kept clean and dry. Spilt oil or grease must be removed immediately. Maintenance must always be carried out with the machine stopped and disconnected from the electricity and the compressed air supply. Never allow unauthorised personnel to service the machine.

Do not perform any maintenance without prior authorisation.

Always follow the procedures detailed for maintenance and technical assistance.

Do not insert any part of the body, including limbs and fingers, in sharp-edge openings, that are not suitably protected. Do not use petrol, solvents or other flammable liquids as cleaning agents. Only use authorised non-flammable and non-toxic solvents.

Compressed air should not normally be used for cleaning purposes, but if this cannot be avoided, wear safety goggles with side guards and do not exceed a pressure of 2 atm. (1.9bar).

When servicing or checking the machine, do not use a naked flame as a light.

Do not lubricate the machine while it is in operation.

In the case of electrocution, the victim is probably unconscious and need to be detached from the power source.

Caution: this operation is extremely dangerous because the victim also act as a conductor and touching him would result in electrocution. Before touching the victim, disconnect the power supply. If this is not possible, move the victim away using a non-conductor, such as a wooden stick or a PVC pole. Contact a doctor immediately and arrange for the person to be taken to hospital.

When servicing motors or carrying out any other interventions off the ground, the use of safety steps is mandatory.

INTRODUCTION

1.1 FOREWORD

Some illustrations appearing in this handbook depict the machine, or parts of it, without the guard or safety devices. This does not mean the machine is to be used under these conditions. The only purpose is to allow the operator to understand the operating principle.

CONSERVATION AND USE OF THIS HANDBOOK.

The purpose of his handbook is to provide the users of the machine with clear texts and diagrams, rules and essential instructions for transporting, handling, using and servicing the machine.

Please read this handbook carefully before starting to use the machine. This handbook must be kept carefully in a place of easy access for future consultation. It is important to make sure it is readable at all times, which means protecting it from sunlight, and keeping it in a clean, dry place, preferably right next to the machine.

If the machine is sold, the manufacturer must be informed of the name and address of the new owner/user.

WARRANTY (IF PROVIDED)

For the warranty to remain valid, the machine must not be tampered with for any reason. Please contact the manufacturer directly if any defects are found on delivery or during the warranty period.

Any attempts by the user or an authorised person to dismantle, modify or in general tamper with the machine or any of its parts will invalidate the guarantee and relieve the manufacturer of all liability connected with damage or injury, resulting from such action.

The manufacturer is also relieved of liability in the following cases:

- incorrect installation
- improper use of the machine or use by unsuitably trained personnel
- use not in compliance with the laws applicable in the country of installation
- failure to service the machine as required or incorrect servicing
- use of non-original or non-specific spare parts
- partial or total failure to follow the instructions provided.

INTENDED USE

The machine must only be used for the specific purpose for which it was built.

Do not use the machine if:

- it has not been connected correctly to the main installation
- it has not been connected correctly to the electricity supply
- it has not been connected correctly to the compressed air supply.
